## SPEAKER BIOGRAPHIES



**Bonnie Martin-Harris**, **PhD**, **CCC-SLP**, **BRS-S**, is an internationally renowned lecturer, researcher and clinician. She is the Founder and Director of the MUSC Evelyn Trammell Institute for Voice and Swallowing in Charleston, SC. Her latest research project was a rigorous, five-year MBS study testing whether a standard vernacular, protocol, evaluation measurement, and reporting method could be validly and reliably executed for the MBS. This study produced the *Modified Barium Swallowing Impairment Profile (MBSImP)*.



**Jerry Hoepner**, **PhD**, **CCC-SLP**, presents nationally on the topics of cognitive and communication disorders resulting from brain injury and on acquired language disorders in aphasia. Dr. Hoepner is an Assistant Professor in the Communication Sciences and Disorders Department at the University of Wisconsin at Eau Claire. His current research examines the role of partners in supporting the success of everyday interactions of individuals with traumatic brain injury. Clinically, Dr. Hoepner specializes in the use of routines to reduce demands on working memory and executive functions.



**Donald MacLennan**, MA, CCC-SLP, is a clinician with the Minneapolis VA Polytrauma Transitional Rehabilitation Program working with veterans to establish community independence. He has 28 years of experience working with persons with TBI, providing cognitive rehabilitation across acute, outpatient, community reentry, and home care settings. Mr. MacLennan was recently involved in a joint project with VA and Department of Defense to provide guidelines to SLPs for treating TBI. In 2008 he received the Rick L. Bollinger Clinician of the Year Award, a national award recognizing clinical excellence within the VA.



Robert G. Winningham, PhD, specializes in applied memory abilities and conducts research on the cognitive abilities of older adults. This clinical research has led to the development of novel approaches that increase the efficiency of SLPs and OTs in their work with persons with brain injury including those with TBI and progressive cognitive loss associated with aging and dementia. Dr. Winningham has given more than 350 invited presentations on cognitive rehabilitation. Currently he is Co-Director of the Geriatric Wellness Center and Chair of the Psychology Division at Western Oregon University.



Cathy L. Lazarus, PhD, CCC-SLP, BRS-S, is one of the premier researchers in the field of Speech-Language Pathology. She has conducted extensive research and lectured internationally for over 20 years on swallowing disorders in the head and neck cancer population. She is faculty at NYU School of Medicine, as well as Director of Research for the Thyroid Head and Neck Research Center at Beth Israel Medical Center in New York City.



James L. Coyle, PhD, CCC-SLP, BRS-S, is a clinician, researcher, and author with interests in evidence-based practice, meta-analyzing research, and dysphagia outcomes measurement. Dr. Coyle is an Assistant Professor in the Department of Communication Science and Disorders at the University of Pittsburgh, where he teaches Dysphagia, Medical Speech Pathology, Neuroscience and Head & Neck Anatomy coursework. At the University Medical Center he performs dysphagia consultations and trains SLP students in acute and intensive care practice. In addition, Dr. Coyle has served as a reviewer for *Dysphagia*, the Journal of Speech, *Language and Hearing Research*, the American Journal of Speech Language Pathology, and other peer-reviewed journals.



Paula A. Sullivan, MS, CCC-SLP, BRS-S, is a Speech-Language Pathologist in the Department of Neurology/Speech Section within the North Florida/South Georgia Veterans Health System in Gainesville, FL. Her clinical expertise and research is focused on swallowing disorders in head and neck cancer and at end of life. Ms. Sullivan has published numerous articles and book chapters, and co-authored books related to these topics. She is an ASHA Fellow and a former coordinator of ASHA's Division 13, Swallowing and Swallowing Disorders.



Tom Franceschini, MS, CCC-SLP, is a highly sought-after speaker on the topic of Dysphagia Management, having educated thousands of Speech-Language Pathologists, Nurses and other healthcare professionals throughout North America and Europe.
